Customers and Quotes

Genesis Global will provide you with an accurate phone, written, fax, or e-mail quote. Quoted and actual price/availability/delivery on all equipment may slightly vary due to time elapsed between quote and purchase, market supply/demand conditions, inventory status and equipment's internal configuration. All equipment is subject to prior sale. All orders require a formal purchase order or signed credit card form.

Payment and Sales Tax

Genesis Global accepts payment via Wire Transfer, Cashier Check, Money Order, Visa, MasterCard, and American Express for all purchases. For customers on Net Terms, Genesis Global accepts Company Checks. All payments must be in US Dollars. Current billing addresses and phone numbers must be included with every order. Your credit card is charged at the time your order is shipped – not when the order is placed. Genesis Global charges sales tax to all customers in California.

Customer will be responsible for any costs or fees, including court costs and reasonable attorney fees incurred during collection efforts or litigation stemming from purchaser's breach of this invoice or Net Terms agreed to. All overdue invoices are subject to late fees and 18% interest charges.

Terms of Delivery

Genesis Global will mail/ship upon receipt of a formal purchase order (unless otherwise arranged). All sales are subject to availability. Special care is taken in the packaging of the equipment to ensure it is not damaged in transit. However, sometimes carrier damage occurs. Genesis Global is not liable for any damage that occurs during the shipment of any item. Any claims must be presented to the carrier.

Errors and Omissions

Due to human error, the Genesis Global staff may unintentionally communicate incorrect or outdated information regarding inventory, prices, or policies by way of verbal or published information.
